Registration Procedures

Team Registration...

U11 through U19 teams must complete a Team Entry Form and submit it along with \$500. Checks should be made Payable to **Eastern District**.

All registration forms and deposit must be in our possession by June 26th.

Teams can mail their entry form and check to the address shown on the Team Entry Form.

We will also accept Registration at the Marriot Hobby - Sunday, June 26th between the hours of 2pm and 6pm.

Teams will be assigned to the appropriate association based on there qualifications(e.g. A team registers as Super 2 and then gets moved into Div 1 will be moved into EDDOA. or; A team registers as Div 1 and should be Super 2 will be moved to their appropriate Association.)

Team Requirements...

A team must be in “**Good Standings**”.

The following matrix will be used to determine eligibility.

To be eligible to return with your seeding, with the exception of U-19 which has no core requirements, a team must return greater than 50% of their players rostered from the previous season. For Super 2 teams the core amount is determined by the number of players active on a team’s roster at the end of the Fall Competition. For Div 1 teams core players are considered to be any eligible player that was rostered to a team during the Fall and/or Spring Competitions...see examples below.

Previous Roster Size	Returning Players
12 or 13	7
14 or 15	8
16 Or 17	9
18 or More	10

Note: SCL and PLW teams may have different eligibility requirements.

Div 1 Core Player Example 1: A player rosters to a team during the fall and then releases from that team, for any reason, but is returning to the team this fall.
Example 2: A player rosters to a team during the fall and then Transfers to another team, this player would be considered as a Core Player to the team they roster with this fall.

Player Registration...

Super 2 Players are registered through their home club and Div 1 and Independent Teams (not affiliated with a club) will register their players through Eastern District Division One Association(EDDOA). Registering of players should follow registration procedures given by the respective organizations.
